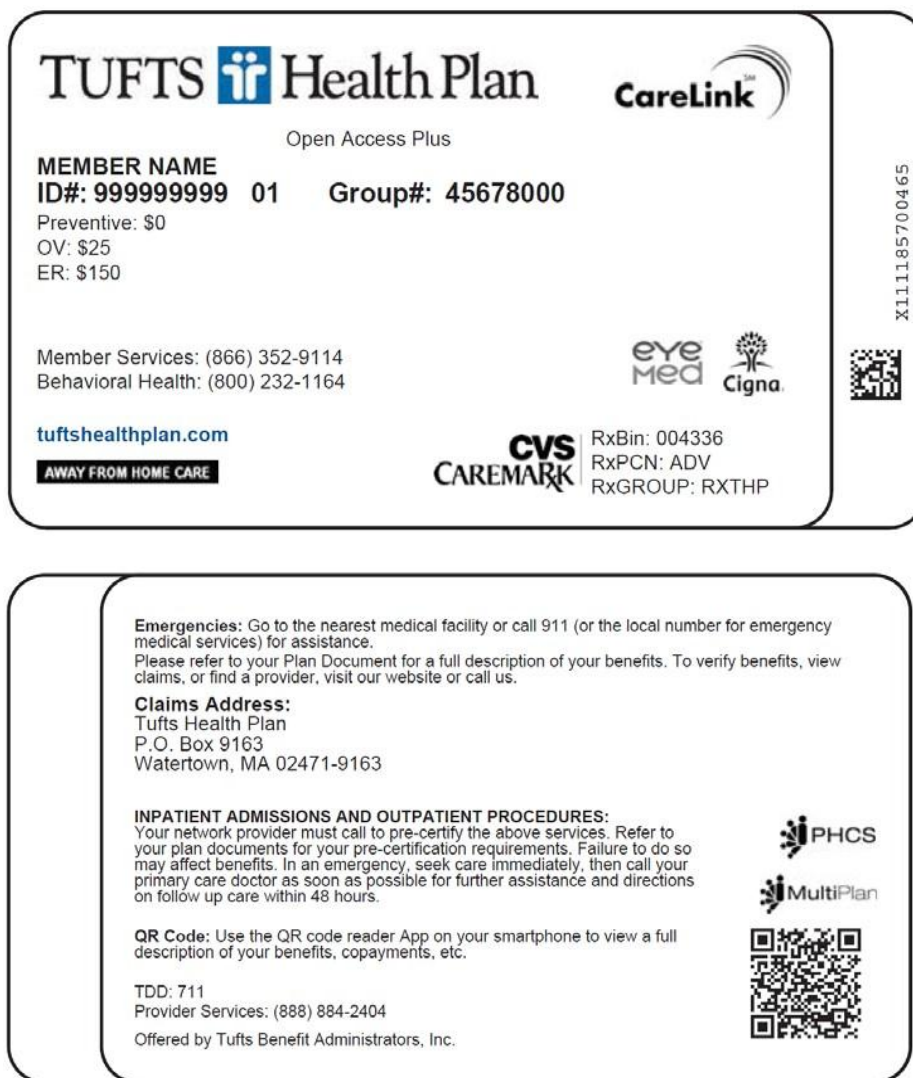

Cigna has a strategic alliance with Tufts Health Plan to offer CareLink®, an Open Access Plan (OAP).

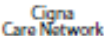

Sample Cigna CareLink ID card (Cigna is primary administrator)

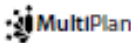
